Live Love Local Campaign Rules

1. **Agreement:** These rules govern the “Live, Love, Local Campaign”. No purchase is necessary to enter the campaign. The act of entering the campaign constitutes acceptance of the campaign rules and the decisions of the campaign sponsors, which decision shall be final and binding on all entrants.

The winner will be contacted by telephone by a representative of the Sponsors, and must reply within 5 days to maintain eligibility. If the potential winner cannot be contacted within this time period or fails to respond to any attempted contact, such potential winner will be disqualified, his/her entry will be declared null and void and the Sponsors reserves the right, in their sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry.
