GENERAL INFORMATION ABOUT LICENSING

The following are the types of business licenses currently offered in the Town of Arnprior. A license in the Town of Arnprior is valid from January 1st to December 31st of a particular year. A license must be renewed on or before January 31st of the next year. Required approvals MUST be obtained before purchasing the license. All approvals should be **attached** to this application form.

Important Notes:

- A business may only operate from a specified location on private property in an area described in the Zoning By-law 4990-01, as amended, that permits such commercial use. **Site plan approval** from the Town Planner MUST be obtained before purchasing the license.
- If vending at a particular location or on private property, a **written approval** must be obtained from the owners of such property.
- In order to issue a business license, a copy of the business' **liability insurance** must be provided to the Town of Arnprior.
- If applicable, a copy of the **TSSA Certified Propane Fitter Inspection** must be provided to the Town of Arnprior.
- A copy of this **business license application** must be returned to the Town of Arnprior.
