a) Zoning By-law Amendment 1/16 Village Creek Subdivision Post Public Meeting – Town Planner

Whereas the Planning Act directs that where a change is made in a proposed Amendment Application after the holding of the public meeting, the council shall determine whether any further notice is to be given in respect of the proposed by-law and the determination of the council as to the giving of further notice is final and not subject to review in any court irrespective of the extent of the change made in the proposed by-law; and

Whereas Council considers the proposed amendment Application 1/16 to be more restrictive than the proposed by-law;

Therefore Be It Resolved That Council directs that no further notice is required to be given in respect to Zoning Amendment Application 1/16.

That Council directs staff to prepare By-law XXXX-16 for amendment to Zoning By-law No. 4990-01, for the subject lands being Lots 31-57 and 80-84, on Plan 49M-76, to amend the zone designation from Residential One Exception Twenty-one (R1-E21) to Residential Two holding (R2-h) in accordance with this report.

Councillor Dan Lynch noted the following:

- Item #3 Page 17 Information from the OPP OPP Billing
 - In response to Councillor Lynch the CAO noted that the Town will base estimates for OPP billing on a combination of past trending, inflation, and labour data in the absence of detailed billing information from the Province.
- Item #4 Page 18 & 21 & 28 Information from the Province of Ontario Shingles
 Vaccine for Seniors; Measures to Reduce Electricity Costs; Celebrate Ontario 2017
 - If you are a senior between the ages of 65 and 70 the Province of Ontario is providing a free shingles vaccine.
 - The province of Ontario is introducing measures to reduce electricity costs. As the Mayor pointed out at the last Council meeting, there was mention of a reduction in electricity costs in the throne speech, with a now proposed reduction for 8% with other incentives. Council will keep the public informed as this continues to evolve.
 - The province of Ontario is encouraging festival and event organizers across the province to apply for "Celebrate Ontario 2017" funding. In response to Councillor Lynch, the CAO noted that there is a team of staff (Recreation, Museum, and Community Development) looking into eligible options for potential application to this funding.
- Item #6 Page 33 AMO Breaking News Water Funding Agreement
 - In response to Councillor Lynch the CAO noted that both Finance and Public Works staff are working on the potential for the Water grants with the federal/provincial levels of government, along with other infrastructure grants

which are all due in October. An information report is planned for Council in October.

 In response to Councillor Lynch the CAO also noted that the Town's FIR's have been submitted on time for the last four years, and thus this will not affect our chances to receive grant funding.

Mayor Reid expressed concern with (Item #1 - Page 13-14) the County of Renfrew's request for a discount in memberships for the Town's Recreation Services, for County Employees.
