6. Matters Tabled/Deferred/Unifinished Business

a) Nick Smith Centre Change Rooms and Renovations Update (Discussion)

The Secretariat Services Coordinator provided a verbal update on the Nick Smith Centre Change Rooms as well as the status of renovations at the Nick Smith Centre. The Secretariat Services Coordinator relayed the Directors of Recreation's comments as follows:

- That subject to grant approval the Service Counters are slated to be made accessible as well as the sand in playgrounds is to be changed to cedar weave.
- The Town is in the process of completing drawings for updating the current pool change rooms. This will enable the Town to have this project 'shelf ready', as the budget does not allow for these changes to be made without funding assistance at this time.

As an interim measure a change room equipped with a shower and washroom can be utilized through a request to the customer service representative.

Discussion ensued among the Accessibility Advisory Committee Members with the following being a summary of comments:

- Investigate if the following changes could be installed as an additional interim measure:
 - Accessible buttons installed on the change room and Community Hall doors;
 - A grab bar installed in the change room showers;
 - One toilet and sink lowered in each change room.
- Committee members suggested training is provided to lifeguards and program employees for teaching and management of children with various special needs. Also, it was suggested that specific programs be offered at the Nick Smith Centre for Special Needs children.

d) Waterfront Trail & Pedestrian Crossing - Update

Chair Mayor David Reid stated the leveling of the Waterfront Trail is to be completed, as part of the future Waterfront development plan.

The Mayor also noted that a curb cut was made on William Street at Hugh Street to enable individuals with wheelchairs or scooters to access Hugh Street North.

e) Arthur Street and Downtown Revitalization - Update

Chair Mayor David Reid noted that sidewalks are being installed on Arthur Street and the Down Town Revitalization, with many accessibility considerations, has been accelerated to a 2 year timeframe for completion.
