Whereas Council approved the recommendation for the plan of subdivision proposed by T. Anas Holding Inc. in September of 2014 and indicated to the approval authority, the County of Renfrew, that the proposed draft plan of subdivision was not premature, that it met the intent of the Provincial Policy Statements and requesting the conditions of draft approval as outlined in the staff report; and

Whereas draft approval was given by the County of Renfrew on August 5, 2015 and will lapse on August 5, 2018 if not granted an extension by the County of Renfrew before the lapsing date; and

Whereas the applicant has requested that Council provide a resolution in support of a request for extension, due to the sale of the subject lands and the intent of the new owners to make application to revise the draft plan of subdivision.

Therefore Be It Resolved That Council supports the request by Madawaska Regional Inc. for a one-year extension to the draft approval of the Madawaska Blvd. Draft Plan of Subdivision (47-T-14002) and that this resolution be forwarded to the County of Renfrew for consideration of approval.
