- It is mandatory for all licenced businesses/ applicants to carry sufficient liability insurance, in compliance with the Town of Arnprior’s insurer.
 - For Vendors of the Arnprior Market who do not carry their own liability insurance or adequate insurance when participating in the Arnprior Market, a Facility User Liability Insurance Program (FULIP) is available at time of booking.
