

THE CORPORATION OF THE TOWN OF ARNPRIOR

BY-LAW NUMBER 2527

A BY-LAW OF THE TOWN OF ARNPRIOR TO REGULATE THE OPERATION OF MOTORIZED SNOW VEHICLES IN THE TOWN OF ARNPRIOR

WHEREAS the Motorized Snow Vehicles Act, 1968, as amended authorizes a local municipality to pass by-laws regulating, governing or prohibiting the operation of motorized snow vehicles within a municipality including any highway therein or part or parts thereof;

BE IT THEREFORE ENACTED AS A BY-LAW OF THE TOWN OF ARNPRIOR:

1. "Motorized Snow Vehicle" means a self-propelled vehicle designed to be driven exclusively on snow or ice or both.

2. (a) Except for the purpose of crossing at intersections designated in the following paragraph, no person shall, at any time, operate a motorized snow vehicle upon the following Streets or parts thereof;

Daniel Street	Madawaska Street	Baskin Drive
Madawaska Street	Daniel Street	Elgin Street
Elgin Street	Daniel Street	Division Street
McGonigal Street	Daniel Street	Edward Street North
Madawaska Boulevard	Daniel Street	Railway Lines
Ottawa Street	John Street	Harrington Street
John Street and its extension northerly	William Street	Chats Lake

(b) Crossing of the Streets enumerated in (a) above shall be made only at the following intersections:

John Street	at Victoria Street intersection
Daniel Street	at Atkinson, William Galvin and Edey Street intersections with travel being permitted for crossing purposes on Daniel Street from Atkinson to William Street and from Galvin to Edey Street.
Elgin Street	at McLachlin Street intersection

3. No person shall operate a motorized snow vehicle on any Street or Highway not above enumerated except for the sole purpose of travelling to any area outside the municipality or any property within the municipality where such operation is permitted and return.

4. No person shall operate a motorized snow vehicle upon any private property within the Town of Arnprior; provided that this section shall not apply where such person establishes that permission to use such property has been obtained from the owner or tenant thereof.

5. No person shall operate a motorized snow vehicle in the Town of Arnprior

No person shall operate a motorized snow vehicle within the limits of the Town of Arnprior at a greater speed than 15 miles per hour.

6 7. No person shall operate a motorized snow vehicle on any sidewalk or bridge in the Town of Arnprior nor shall any person bring upon or use upon any cemetery parks and play grounds hereinafter set forth, a motorized snow vehicle:

(a) Arnprior Municipal Park

more particularly described as Lot Letters O and P according to Registered Plan Number 33 for the Town of Arnprior excepting therefrom those parts described in Instruments Numbers 10363 and 10860.

(b) Caruso Street Playground

More particularly described as part of Reserve on Harrington Estate according to Registered Plan Number 32 for the Town of Arnprior bounded on the north by Caruso Street, on the west by Division Street, on the south by the southerly limit of the east half of Lot 5, Concession 13 and on the east by the lands described in Instrument Number 77769.

(c) Edey Street Playground

More particularly described as Block B according to Registered Plan Number 301 for the Town of Arnprior.

7 8. The owner of a motorized snow vehicle for an offence hereunder shall be liable to a fine upon conviction of not less than \$20.00 and not more than \$100.00 exclusive of costs recoverable under the provisions of the Summary Convictions Act unless at the time of the contravention the motorized snow vehicle was in the possession of some person other than the owner without the owner's consent and the driver or operator of the motorized snow vehicle, not being the owner, shall also incur the penalties herein provided for any contravention.

X 9. By-Laws Numbers 2401 and 2402 are hereby repealed.

Y 10. This By-Law shall come into effect upon approval by the Department of Transport.
